IFA Convention Golf Cart Safety Requirements

The 2019 IFA Convention hosts, Manchester Fire Fighters Association, have agreed to the following requirements for this year's Convention. **Upon arrival and prior to admittance to the campgrounds, each cart will be registered with the host department.** Registration forms are available on the Convention website. Having a form filled out and current proof of insurance for each cart ready for each cart will speed up the time it takes to register a cart for use at the convention. The following criteria need to be met:

1. Carts will be required to have hard wired lights front and back. This will include all rented carts.
2. Carts will be required to have proof of insurance. A Certificate of Coverage will need to be presented. Certificate needs to show a minimum of \$20,000 of liability coverage and the specific make, model and serial number for the cart.
Golf cart owner, please contact your insurance agent to discuss this: If you do not have specific insurance on your golf cart, your Homeowners Policy only covers your cart in your driveway and when on a golf course.
3. The Iowa Code, Sections 321.20B (1 a & b) (Proof of Security) and 321A.21 (Motor vehicle liability policy__ defined) require all motorized vehicles used on public areas to have insurance.
4. Registration form will require information regarding the owner and the operator of the cart at the campgrounds.
5. Upon completion of registration form and successful inspection of carts, a numbered identification tag will be affixed to the cart and admission to the campground is permitted.

- This policy is between the golf cart owner and the insurance company.
- There is no cost to register golf carts for admittance to the campground.

As in past years, golf carts are the only motorized recreational vehicles permitted for use in the campgrounds. ATV's, 6 wheel Gators, Mules, and other high speed vehicles are reserved for use by the host department.
